Thread - Black 6/0  
Hook - 1X Long Nymph 8-16  
Tail - Mallard Flank, Dyed Wood  
Duck  
Abdomen - Cream Dub  
Rib - Brown Silk/Floss  
Wing Case - Mottled Turkey Quill  
Thorax - Cream Dub

Legs - Cream Hen Hackle - Beard Style

Tie with or without bead. Good late spring fly.



### MEDIUM ALL-PURPOSE NYMPH

Thread - Black 6/0  
Hook - 1X Long Nymph 8,10,12,14  
Tail - Pheasant Tail fibers  
Rib - Fine Gold Wire  
Abdomen - Grayish Brown underfur from Natural Red Fox  
Wing Case - Mottled Turkey Quill  
Thorax - Same as Abdomen  
Legs - Brown Hen Hackle Beard Style

Tie with or without bead. This is a good autumn fly.

Many of you who attended our meetings in the spring are aware of Assembly Bill A3275. This bill wants to change the composition and revise the authority of the Fish and Game Council. CJTU is opposing this bill and the companion Senate Bill S2041. The Assembly Bill is out of committee with amendments and has had a second reading. This is bad news because if the Senate bill comes out of committee the bill may be put on the floor for a vote.

The bill distresses me for several reasons. One, there is no provision for a sportsperson to sit on the council and slots for only two farmers. Secondly, the bill was transferred from the Assembly Agriculture and Natural Resources Committee to the Assembly Environment and Solid Waste Committee, which I feel was a underhanded move the push the bill through. And finally, as currently written the bill deletes the use and development of fish and game for public recreation and food supply.

Here is the amendment summary:

The Assembly and Solid Waste Committee reports favorably and with committee amendments Assembly Bill No. 3275.

This bill, as amended, would change the membership of the Fish and Game Council. Under this bill, the council would be composed of seven members, of whom two members would be farmers. The seven members would be chosen with due regard to the person's knowledge of and interest in the conservation of fish and wildlife, and without regard for geographic representation of the regions of the State. The seven members would be appointed by the Governor with the advice and consent of the Senate. In addition, this bill would require that no member of the council have a direct personal financial interest that might reasonably be expected to impair the person's objectivity or independence of judgment.

Under current law, there are 11 members on the council, chosen with due regard to the person's knowledge of and interest in the conservation of fish and game, as follows: three farmers, recommended by the State agricultural convention to the Governor for appointment; six sportsmen, recommended by the New Jersey State Federation of Sportsmen's Clubs to the Governor for appointment; one public member knowledgeable in land use management and soil conservation practices; and the Chairperson of the Endangered and Nongame Species Advisory Committee established pursuant to "The Endangered and Nongame Species Conservation Act." In addition, the current farmer representatives and sportsmen representatives are chosen with regard

to geographic representation of the State, with one farmer representative and two sportsmen representatives chosen from the northern, central, and southern regions of the State.

This bill would also revise the authority of the Fish and Game Council. This bill expands the duties of the council to include: investigating the use of non-lethal alternatives for dealing with wildlife conflicts; exploring eco-tourism opportunities to promote the State's diverse wildlife; and pursuing opportunities to preserve land for wildlife habitat.

In addition, under current law, the Fish and Game Council is authorized to adopt the State Fish and Game Code for the purpose of "providing an adequate and flexible system of protection, propagation, increase, control and conservation of freshwater fish, game birds, game animals, and fur-bearing animals in this State, and for their use and development for public recreation and food supply." This bill would provide that the code is for the purpose of providing a properly managed and balanced system, and would delete the consideration for use and development of fish and game for public recreation and food supply.

Lastly, the bill makes various technical amendments to the statutory text to update references to the Department of Environmental Protection and the Division of Fish and Wildlife, and to update statutory references.

The committee amendments to the bill provide that two of the seven members of the council shall be farmers.

The smaller council will only provide for more split votes and less action. Sportspersons are this state's first environmentalists, purchasing over 300,000 acres of land for public recreation through the direct sales of fishing and hunting licenses. While the public has supported public questions concerning the purchase of land for open space, sportspersons were the first to do so, because we know preserving habitat preserves our fish and game resources.

The greater question at hand here is who controls our natural resources: a diverse council like we currently have or a hand picked few.

What should you do? Contact your Assemblypersons and Senators and strongly voice your opposition to A3275 and S2041. To find your Legislative members go to <http://www.njleg.state.nj.us/districts/municipalities.asp> and find your town and click on the link. Call, write or email them and remember that this November the entire Assembly is up for election so check which candidate supports your issues.

Fall time is trout time in New Jersey. In early October, The NJ Division of Fish and Wildlife is set to stock 20,000 two year old fish averaging 14-16 inches in length in the major trout streams of North Jersey as well as selected lakes and ponds in Central and South Jersey a week later. In addition a further 1000 surplus brood stock trout averaging 17-21 inches will also be stocked. Go to the New Jersey Division of Fish & Wildlife web site at [www.njfishandwildlife.com](http://www.njfishandwildlife.com) for dates and specific stocking locations.

For a second consecutive year, by way of a generous anonymous donation, Trout Unlimited will also be stocking the Ken Lockwood Gorge WMA on the South Branch of the Raritan River with a mixed size group of fish at around the same time. You'll need to stay tuned for details on that. Remember that the state's fish are all nice size and will provide many anglers with the opportunity to catch the largest fish of the year. Last year's program was generally well received and this year there is a twist!

Shannon's Fly and Tackle in Califon is having a Fall Stocking beginning on September 15, 2007. 250 Brook, Brown, and Rainbow Trout will be stocked in and around Califon courtesy of GBW Insurance in Flanders, NJ, Shannon's Fly and Tackle of Califon, CAMPA (Califon Area Merchants and Professionals Association) along with donations from our customers. The trout will range from 11-28 inches in length and Vern Mancini of the Musky Hatchery is donating an additional five trophy trout. We thought it would be nice to stock some smaller fish as well as some real nice fish to compliment the state's stocking. Combining all of these efforts really makes for some good fishing. Finally, "Bubba" is back! The Grand Prize of a Scott E2 fly rod will go to the lucky angler who catches and releases "Bubba", a trout of legendary proportions complete with a jaw tag. We just want the tag number and a picture of the fish. With enough rain and cool temperatures this summer, there are also plenty of holdover trout in New Jersey's better trout streams but this fall, the South Branch is the place to be!

Insect activity will increase as the weather cools going into and through September. Isonychia or Slate Drakes are already hatching after their usual summer-time lull. In the fall they are a little smaller, size 12-14 being about average and they will hatch through early to mid October. September is a great month to fish the Whitefly hatch here in New Jersey. The hatch consists of two species that will both hatch later in the day. The first, Ephoron Album is a cream-yellow mayfly best imitated by a Blond Wulf size 12-14. The more well known is the Ephoron Leukon traditionally imitated by a White Wulf size 10-12. I've also decided to stock the venerable White Miller in size 12 because I like the size and color profile this fly brings to the table. Tan Caddis

size 16-18 are a staple of our streams but the smaller caddis will be joined in late September by the Great Autumn Sedge best imitated by an Orange Stimulator size 10-12

Blue Winged Olives are a prime feature of Eastern fall fly fishing; sizes usually run from 16-20. Terrestrials such as Hoppers and Ants should not be overlooked. The Hopper Dropper consists of a floating Hopper with a Beadhead Pheasant Tail nymph size 16-18 suspended off of the bend in the Hopper's hook. This is a great pocket-water prospecting tandem rig. Pheasant Tail nymphs in size 14-20, Hare's Ear nymphs size 14-16 and Prince nymphs size 12-16 are all must have flies in the fall. Don't neglect classic streamers such as the Mickey Finn, Black Nose Dace, and Grey Ghost either in sizes 8-12 as forage fish populations will be at their highest.

As October wanes, mayfly activity will dwindle. Caddis are hardy, I've seen them into early December on warmer days. This is the time I fish with nymphs or streamers as previously mentioned, but I really like scuds. They are in the water all year but look for submerged logs or vegetation for the best concentrations of them. Best colors include grey, olive, or tan depending on the day but they catch fish and big fish too. Just have a few in sizes 14-16 and you won't be sorry. Fish them either alone or as the back end of a tandem.

Finally, the Division's team of biologists was busy this summer electro-fishing. Mike McAuliffe and I helped out along with Rich Balak and Rick Axt. Fish populations were strong (about 60/40 Browns to Brookies just like last year) but as Head Biologist Shawn Crouse said "There's more than just trout in a trout stream." Try volunteering for one of these and you'll learn a lot. You'll see Brook Lampreys, Tessellated Darters and Slimy Sculpin. We look forward to seeing everyone catch some nice trout this fall and we can all take a little pride in our combined efforts to make the next few months something to remember!

Kids Fishing Education Day for family members of Central Jersey Trout Unlimited will be held at the Pequest Hatchery rain or shine 10:00 am to 3:00 pm. We had a great time last year. All kids age 8 and above that are family of CJTU members can also invite a friend to come along. We need to know the number of adults and kids that will attend. Any chapter member is invited to assist the youngsters. Pizza lunch will be provided.

We will have spin cast outfits for the kids -- with barbless hooks and we will also supply worms. Lures are not allowed. You can bring a fly rod or bring your own fishing outfits as long as there is someone accompanying the youngster. Safety glasses are supplied for those that aren't wearing plain glasses or sunglasses.

The day will start in the auditorium where you will be welcomed by a member of the Pequest Hatchery and Resource Education Center. Then up to the trout education pond for a short talk on fishing ethics etc, casting lessons, and fly-tying lessons for those that want to learn to tie a wooly-bugger prior to fishing the pond. If it rains, fly-tying will take place in the auditorium, but then, everyone will don their foul weather gear and head up to the pond to hook those -- up to 6 pound rainbows.

Indoor activities include a sportsmen's flea market, wildlife artists and taxidermists, along with guides and outfitters displaying their services.


And of course....The kids get another shot to fish the teaching pond!
