DAY TRIP TO MUD RUN, PA

APRIL 22, 2005

Mud Run flows right through the heart of Hickory Run State Park, one of the most scenic parks of the Pocono Mountain Range. Once inside the park it won't be hard to imagine traveling through Vermont, New Hampshire, Montana or even Colorado. There is plenty of wildlife in the park and abundant insect life in the stream. POLITICAL BEAT

A2642 and A2852 are still in committee, and are alive and well.

Both bills would amend current law to provide that the Commissioner of Environmental Protection shall select the Director of the Division of Fish and Wildlife, and the director shall serve at the pleasure of the commissioner. Under current law, the Director of the Division of Fish and Wildlife is selected by the Fish and Game Council, subject to the approval of the governor and serves at the pleasure of the council. These bills would also amend current law to make all regulatory and policy decisions of the Fish and Game Council subject to the approval of the Commissioner of Environmental Protection.

These bills shift control of our resources from science to political appointees. You all know I want good science behind the decisions on how to manage our fish and game resources. Hunters and fishers pay via license fees for the science and management of fish and game in this state. Those funds cannot be used for anything else and go back to the resource for all to enjoy. I want a non-political body that will base its decisions on science from field biologists not a single political appointee who may be beholden to the governor (and those checks).

Honorable (Assembly-person)

As an avid sports-person living in New Jersey, I would like to express my strong objections to Assembly Bill 2642 (A2852).

I support the current Fish and Game Council and strongly object to any changes to this body. The Fish and Game Council is doing an outstanding job in managing our fish and game resources, based on science. I have four major objections to A2642 (A2852): first the language removing "for their use and development for public recreation and food supply"; second new members to the council would be appointed by the governor and could have no expertise in fishing, hunting, farming and trapping issues; third the bill gives ultimate power to the Commissioner of Environmental Protection who can overrule the council; and finally it moves the council from a body that makes decisions based on science, to a political body.

A2642 will negatively impact the fish and game resources that I love. So in the strongest language possible, I respectively request that you WITHDRAW Assembly Bill 2642 (2852). I cannot support A2642 (A2852) and respectively request you do not.

So at this, the beginning of our year, please take a moment to contact your assembly person or senator and let them know, you expect them to oppose any changes that jeopardize your right to fish.

MARCH MADNESS

Wintry weather ruined the March 8th membership meeting and the forecast for our Little Lehigh fishing trip was much of the same. Fortunately, the decision to move the date back one week paid off. St. Patrick's Day was a great day in more ways than one. The day began with the drive out to Allentown with my new good friend, Rich Post, in his spacious, comfortable and souped up Ford pick-up truck. It wasn't the vehicle that first impressed me, but rather, his collection of fine liquor, but I digress. At eight AM the sun was fighting its way out from the clouds. Once the fight was over, the sun never went back in. We all arrived at the Heritage Section at nine AM for breakfast. Hal Fish arrived much earlier and fought several nice rainbows before we all got there. It was a cold evening and the sun had much catching up to do. It was chilly and at most 39 degrees outside. The water was almost clear and 44 degrees. There wasn't much going on, on the surface of the water. Still, you could spot scores of trout, especially the golden trout.

By ten, we had finished up the last of the coffee, and were stringing up our rods. I started with a tiny size 18 pheasant tail and a tiny size 22 bright green nymph. Within the first half hour I hooked a rainbow, brown and even one of the golden trout. I changed my bottom fly to a tiny size 20 baetis nymph and continued to catch several more. Hal experienced much of the same. By mid day Hal caught over a dozen. "Everything I tied on, I caught a fish on. I could do no wrong today", he said. David Hart also had an exceptional morning. He was a man of few words that day but smiling from ear to ear. We all were.

By eleven thirty it was in the upper 40's, and trout were rising everywhere. I witnessed some fish jumping entirely out of the water chasing after emerging flies. I didn't know what was hatching, but it sure was small. From a snagged branch off the bottom of the stream I found tiny baetis nymphs and had the very same imitations in my vest. BWOs dry and emerging were winning combinations that day. I took off most of the weight from my tippet and fished successfully the rest of the morning in the film.

At lunch time we all gathered and ate together at a picnic table near the water. It was 50 degrees and very comfortable. We talked about our ups and downs of the morning. Harvey Roberson hadn't caught anything until Hal tied on for him the right fly and pointed to the right spot to fish. My new friend Rich also had a rough morning on his first visit to the Little Lehigh. Of course, Hal only added insult to injury when he said, "You know, it took me two years before I caught my first fish here". To make up for it, Hal gave Rich one of his shamy worms which seemed to make the difference for him. After lunch he caught and rolled several nice fish including a nice golden trout, too.

By four or four thirty we were all off the stream. It was certainly tougher fishing in the afternoon. When we arrived we were alone in the Heritage Section and by the early afternoon a dozen others had joined us. Though the trout were still feeding on the surface, they were very selective.

Fishing during the week obviously has its advantages, and I hope with enough advance notice more can join us.
